

Dear students,

the summer semester 2020 also places high demands on all participants in terms of examination law and technology. The faculty UWUR aims to limit the disadvantages for students resulting from the corona crisis as much as possible, but is dependent on the cooperation of the students in this process. Because: The organisation of the examinations has to consider the health-protecting requirements, among other things 10 m² have to be planned as area per student. In order not to have to extend the exam phase well into August, we need planning reliability with regard to the number of participating students. We therefore expect all students to think carefully about who really and seriously wants to take part in the respective exam, so that we do not plan too large rooms that are missing elsewhere. Careless registrations and cancellations are therefore harmful to everyone.

Registration and deregistration for exams is done via QIS. Therefore, please register for the exams as soon as possible so that the organization of the exams can take place in the best possible way. **In order to improve planning, we would ask you to withdraw from your registration in case of a desired withdrawal at least one week before the exam date.**

By unanimous circular resolution of 8/9.5.2020 on the organisation of examinations in the summer semester 2020, the Examination Committee of the Department of Environmental Economics/Environmental Law adopted the contents of the Department Council resolution of 24.4.2020 as the **decisive execution specifications for the examinations in faculty UWUR this semester**. The following regulations apply:

1. Withdrawal from the examination is possible until the day of the examination. In the summer semester of 2020, proof of good reasons will not be required. Written examinations handed in during the examination will be evaluated.
2. In order to compensate for the restrictions on attendance at lectures caused by the corona pandemic, students are released from the obligation to take part in the examinations of the summer semester, i.e.
 - a) There will be no attempt count for the examinations of the summer semester 2020.
 - b) A failed compulsory attempt (either according to the 1+4 rule or a repeat examination = 2nd or 3rd examination attempt) and a failed examination will not be counted in the summer semester 2020. For examinations that are not passed, a withdrawal with recognised reason will be recorded in the QIS. This means that compulsory attempts not taken in the summer semester 2020 as well as attempts taken but not passed do not count towards the number of three possible examination attempts according to the applicable examination regulations.
 - c) A written examination that has been passed is counted, but students may take it up at the next examination date for grade improvement. In deviation from the applicable examination regulations, this also applies once in the summer semester 2020 to examinations written in the 2nd or 3rd examination attempt. For these examinations, grades can also be improved on the next examination date. Registration for an irregular (= later than permitted by the examination regulations) grade improvement attempt must then be applied for via the Examinations Office.

d) Students who wish to take part in an examination for grade improvement in the summer semester 2020 can do so in the summer semester 2020 or on the next examination date, e.g. in the following winter semester 2020/2021. Registration for an irregular (= later than permitted by the examination regulations) grade improvement attempt must then be applied for via the Examinations Office. The rule that an attempt to improve grades can only be made once remains in force.

3. Written papers which the students have to produce at home are excluded from this regulation. In principle, they can be carried out, but the delays caused by library closures and restrictions in inter-library loan should be taken into account by generously calculated deadlines for submission and a tendency to generously grant an extension of the deadline upon justified request in individual cases.
